	Nanisa Pereles, Program Analyst, EEOC Office of Field Programs, Field Management Programs Conducting investigations in today's workplaces requires a balance of critical thinking and empathy. It is essential that factfinders be prepared to encounter difficult, sensitive, or challenging scenarios. Often, a person subjected to trauma may have difficulty recalling events, may be afraid to share information, or may not appear to be credible. Because trauma affects everyone differently, there is no one-size-fits-all answer. This session will provide practical tools for navigating those interactions while maintaining a trauma-informed mindset.

Nanisa S. Pereles is a Program Analyst at EEOC. She has served as Supervisory Investigator coaching teams of investigators involved in all types of employment discrimination cases. On a national level, Nanisa has trained and mentored EEO Investigators; served as an EEO trainer for both internal and external customers; and is part of the national development teams for investigative training and compliance materials. Nanisa is a graduate of the Partnership for Public Service Leadership Program. She received a Bachelor of Science in Communications from Southwestern Oklahoma State University and a Master of Arts in Communications from Oklahoma State University.



Diane I. Smason is currently serving as Acting District Director of the Chicago District Office of the United States Equal Employment Opportunity Commission. Ms. Smason became deputy director in January 2020, having started as an EEOC trial attorney in 1998. Ms. Smason oversees the Enforcement, ADR, Federal Sector Hearings, Outreach and Education, and State, Local, & Tribal Programs for the district's offices in Chicago, Milwaukee, and Minnesota. The Chicago District includes the states of Illinois, Iowa, Minnesota, North Dakota, South Dakota, and Wisconsin. While an EEOC attorney, she litigated and supervised a wide variety of matters, including class and systemic cases, under Title VII, the ADA, and the ADEA. She regularly speaks about the EEOC and all areas of federal employment discrimination law.

Prior to the EEOC, Ms. Smason was an associate at Sonnenschein Nath & Rosenthal in Chicago practicing labor and employment law and general commercial litigation. Ms. Smason also served as a judicial law clerk to the Honorable Bernard A. Friedman of the United States District Court for the Eastern District of Michigan. Ms. Smason attended the University of Michigan Law School and has a B.A. in English and Political Science from the University of Pennsylvania.
